Maldives' government has been looking for a long time to decrease its energy dependency from diesel and replace it by clean and renewable energies. Indeed, the cost of diesel goes up to 20% the GDP of the Maldives. "Now they are entering a new era where their goal is to achieve a sustainable and environmental friendly economic growth. Already since 2011, The meeco Group has been in regular contact with Maldivian companies to discuss possible cooperation and projects. Not only is the Villa Group a significant private business company in Maldives but also an active player of local charity and education through its Villa College which just recently signed an agreement with Heilbronn University", adds Mr. Jo Hanns Dieter Trutschler, Directors Sales of The meeco Group, who has also participated in the negotiations.
