points out.

"There is also widespread mining activity, so our market offering is broad. We are also able to offer

compressed air and power requirements for the manufacturing sector. All these various sectors can

benefit from our equipment and services, as they do not have to invest in standby compressors or

generators, but can explore either our short-term or longer-term industrial plant rental (IPR) options. In this way, companies can reduce their capital expenditure and other associated direct ownership costs," he explains.
